



Welcome to 2025 Bloomsburg Fair Camping!

To ensure a safe environment for all campers and visitors, The Bloomsburg Fair Association, Board of Directors, hereinafter called "FAIR" have approved the following policies to be enforced on all Fair-owned, rented, or leased property during your visit, stay of the annual Fair and non-Fair events. To maintain a family atmosphere at all times, Bloomsburg Fair Security has been directed to act as an agent to enforce these policies on behalf of The FAIR. The Town of Bloomsburg, Columbia County Sheriff's Department, and Pennsylvania State Police are also permitted to implement these policies on behalf of The FAIR when they are present on the grounds. Persons entering the facility, and the grounds assume all risks incidental to the event. While visiting or staying at any of our campgrounds or at any events on the The Bloomsburg Fair properties, please ensure you are familiar with and understand The Bloomsburg Fair General Rules and Policies <https://bloomsburgfair.com/rules/> along with the following Campground Reservations, Rules and Policies:

CAMPING REGISTRATION INFORMATION:

❖ Bloomsburg Fair - Outside Event Camping M-LOT / C-LOT / C-LOT EXT

- Camping Area of Fairground - M-Lot, M-Lot Extension
- **\$60** / per Night includes: Water, Electricity, and Sewage ("Black" Water)
- **\$45** / per Night includes: Water, Electricity, (Sewage "Black" Water Dumping will be Included but only at Designated Stations on Fairgrounds)
- **Tent Camping is NOT Permitted** (Unless Advertised)

RESERVATIONS:

- All Camp Sites are First Come, First Serve. We will do the best we can to accommodate your requests, but can not guarantee.
- Campsites with Water, Electric and/or Sewage/Grey Water are Limited
- Reservations will be accepted in the order they are received - Mail, Fax or Email
- Email will be sent to confirm your space and payments.
- Payment is Due at time of Reservation
- Camping Permits will not be issued to anyone under 18 years of age. Groups of campers under 18 years of age must have at least one (1) member over 18 years of age per campsite to register and to accompany the camper at all times.
- The individual whose name appears on the reservation as the applicant is responsible for all members of the group and must be present at the campsite
- At time of arrival, please register at the campsite office and pick-up your packet and permits before going to the campsite.
- Upon registration, camper must provide attendant with driver's license, camper/motor home and tow vehicle registration and a phone number where they can be reached in case of an emergency
- Camping is at your own risk - The Bloomsburg Fair is not responsible for any accidents or damages to property while camping, staying or visiting the campground or fairgrounds property.

CAMPSITE OCCUPANCY:

- Campsite occupancy is limited to a maximum number of eight (8) people per campsite, including visitors.
- Persons camping under eighteen (18) years of age must be accompanied by an adult.
- Children may not be left unattended in the campground without adult supervision.
- Visitors are subject to all Bloomsburg Fair Rules and Policies along with Campground Rules, Regulations and Restrictions.

VEHICLES:

- Maximum of One (1) Vehicle is permitted on any Campsite at one time.
- Parking Permit must match Campsite - RV/Trailer and Spot - and Displayed at all times.
- Any additional vehicles must be parked in the designated overflow parking lot. Violators will be towed at their expense.
- No parking on the roadways
- Sleeping in Vehicles is not permitted on Fairgrounds property.
- Speed Limit is 10 mph.

AMENITIES:

- Outside Event Amenities vary according to camping area and event. Please contact either event or fairgrounds for additional information. admissions@bloomsburgfair.com
- Generators - Must be turned off at 10:00 PM and can be restarted at 7:00 AM - If you require a generator to be used all night long, please make note when registering.
- Gray Water (From Washing dishes, food preparation, bathing, hand washing, etc.) should be collected and disposed of in our dump station. By State Law and for sanitation reasons, drain hoses are not allowed to drain out onto the ground.
- Septic Waste ("Black Water") should be directed to the sewer hookup (if the campsite is so equipped).
- Waste Disposal - Campers are responsible for preventing all wastewater ("grey" and "black" water) from running onto the ground. All wastewater must be disposed of in the dump stations, or sewer connections on the site where available.
- Gray/Wastewater from RV's and portable toilets/showers must be caught in holding tanks or other receptacles and deposited at the dump station.
- Water Spigots are provided at limited spots for additional fees.
- Washing vehicles, camping equipment, or anything that produces gray water to be discharged on or around the campsite is prohibited.
- Swimming Pools of **ANY** kind are strictly prohibited.
- No filling of truck beds or any other pools with water from Bloomsburg Fair spigots.
- Washing pets is prohibited. **(Check to see if event allows animals)**
- Adapters - The Bloomsburg Fair is not responsible for providing adapters for electrical hook-ups. Please see form for options.

QUIET HOURS:

- Quiet Hours are observed from 10:00 PM until 7:00 AM the following morning. Failure to observe this rule may result in eviction from the campground.
- Any unreasonably loud noise is prohibited at any time.

PETS:

- **Pets are generally prohibited unless specific events and the FAIR explicitly advertise otherwise.**
- PPP - Pets on Premise Permit - If pets are permitted at the event, please advise if you will have a pet on the premises. Pets require a Pets on Premise Permit, which will be distributed and enforced. This permit must be displayed at all times.
- Please carry proof of vaccinations with you if you have a pet on premise.
- Wild, exotic, vicious and/or aggressive pets and livestock are not permitted in the campground.
- Excessive barking or disturbance by pets is prohibited at any time.
- **ANIMALS MUST BE ON A LEASH - NO EXCEPTIONS**
- Pet owners must dispose of all pet waste in dumpsters or pet doggie clean-up stations.
- Additional fees will be applied if animal waste is left at the campsite.
- Do not leave pets unattended.
- You are responsible and liable for your pet at all times.

GENERAL RULES:

- Common Courtesy - Do not cross over or walk through other campsites.
- Fireworks, Firearms, Explosives and Projectile-Firing Devices are prohibited
- No fire rings, fire pits or open fires allowed
- Garbage must be placed in the dumpsters which are located throughout the camping area.
- Campsites must be kept clean during occupancy and cleaned upon departure.
- Do not leave garbage bags on the site.
- If the campsite is not left clean upon departure, a clean-up fee will be imposed.
- **NO REFUNDS**
- Management reserves the right to evict any and all violators of the rules and regulations without refunds and to remove persons or animals which are considered detrimental to the health, safety and welfare of management or others using the campground and facilities.
- It is further agreed that any breach by the camper or camper's guest of the rules and regulations shall constitute grounds for immediate eviction from the campground with no refund of fees
